OSHA Hazard Communication Standards

The Globally Harmonized System of Classification and Labeling of Chemicals (GHS) was created by the United Nations and serves as the international standard for Hazard Communication. Recent changes to the OSHA Hazard Communication Standards have aligned the United States with the GHS, and training is required to familiarize employers and employees on these changes by 12/1/13. OSHA created the lockout/tagout standard to cover the servicing and maintenance of machines and equipment in which the "unexpected" energization or start up of the machines or equipment or release of stored energy could cause injury to employees.
